### May 2023 Monthly Sales Report

BizLink Holding Inc. (TWSE code: 3665) announced that consolidated net sales for May 2023 totaled US\$ 143,898 thousand\*, an increase of 2.08% MoM\*\* and a decrease of 8.82% YoY\*\*\*. The year-to-date consolidated net sales for 2023 reached US\$ 701,552 thousand, a decrease of 2.83% YoY\*\*\*\*.

#### Monthly Update (MoM):

Overall shipments continued to slowly improve from the lows experienced early this year as expected.

#### Segment Commentary (MoM):

- Industrial: customers stabilized at prior month levels.
- IT DataComm: overall shipments stayed near last month's levels.
- Automotive: shipments remained relatively firm.
- Electrical Appliance: shipments continued their gradual recovery.
- INBG (43% of total): shipments marginally increased.

\* Consolidation of INBG's financials began from January 21, 2022.

\*\* The consolidated net sales for April 2023 totaled US\$ 140,962 thousand.

\*\*\* The consolidated net sales for May 2022 totaled US\$ 157,822 thousand.

\*\*\*\* The year-to-date consolidated net sales for 2022 totaled US\$ 721,978 thousand.
