BizLink Announces Fourth Quarter 2022 Results

Board of Directors have approved 2022 financial statements: fourth quarter 2022 consolidated net sales were NT\$13,600,543 thousand (US\$432,404 thousand), net income (attributable to shareholders of the parent company) was NT\$922,388 thousand (US\$28,682 thousand), and consolidated EPS (attributable to shareholders of the parent company) was NT\$5.89 (US\$0.1849).

Fourth Quarter Operational Highlights:

- Fourth quarter 2022 sales reached a historical high of NT\$13,600,543 thousand, up +70.03% YoY. ^{Note 1}
- Net income was NT\$922,388 thousand, up +62.16% YoY. ^{Note 2}
- **Industrial:** the capital equipment side began to noticeably slowdown while the other categories of this segment remained firm to up.
- **IT DataComm:** inventory digestion activities persisted within both the Peripherals and the High-Performance Computing categories.
- **Automotive:** electric vehicle contribution continues to drive growth within this segment with new customers gradually becoming bigger.
- **Electrical Appliances:** customers continued to tone down their orders and near-term expectations and consumer sentiment deteriorates.
