May 2022 Monthly Sales Report

BizLink Holding Inc. (TWSE code: 3665) announced today that consolidated net sales for May 2022 totaled US\$157,822 thousand*, an increase of 90.34% YoY**. The consolidated net sales for 2022 reached US\$721,978 thousand, an increase of 89.41% YoY***.

Monthly Update (MoM):

Our Kunshan facility fully resumed normal operations, ramped up production, and restarted shipments to customers to catch up on the volume impact from the April lockdown. Some industries stocked up to ensure safety inventory while raw material and component shortages persisted. Overall, our supply chains are gradually returning to pre-lockdown levels.

Segment Commentary (MoM):

- Industrial: stable shipments from our Malaysia, Singapore, and Southern China facilities with some customers seeing higher inventories due to shortages.
- IT DataComm: ongoing recovery in shipments with bulk of them going to our hubs as customers continued to pull from them.
- Automotive: ongoing recovery in shipments.
- Electrical Appliance: shipments slowed on component shortages and longer lead times.
- INBG: 39% of total sales, recovery in Robotics but slower in Telecommunications due to component shortages.

* Consolidation of INBG's financials began from January 21, 2022.

** The consolidated net sales for May 2021 totaled US\$82,917 thousand.

*** The consolidated net sales for YTD 2021 totaled US\$381,171 thousand.
