BizLink Holding inc. (TWSE: 3665) today reported results for the fourth quarter of 2017. Audited consolidated net sales totaled NT\$ 15,599,207 thousand* (US\$ 512,431 thousand), an increase of 69.41% (calculations made in NT\$. Note 1,2) from the same period in 2016. The EPS for the year was NT\$ 10.68 (US\$ 0.3508). Net Operating Income increased 27.75%. Net Operating Income was 9.92%.

2017 Q4 Highlights

- Information Technology showed strong momentum in Q4.
- Motor Vehicle and Medical Harnesses' pull-in volume remained stable.
- Demand for industrial harnesses has lagged slightly
- The Electrical Appliances business unit's revenue decreased slightly due to seasonal holidays

Outlook for the Subsequent Two Quarters

- Information Technology: Demand for commercial docking stations dipped after year-end holidays; the new model started shipment in Q1.
- Motor Vehicle: Shipments for the new EV model harnesses will increase in the first half of 2018 to accommodate customer's adjusted production schedule.
- Industrial: The semiconductor equipment industry is expected to experience solid demand in the Asia market.
- Electrical Appliances: Revenue growth in the first quarter is expected to be limited due to seasonal factors in China facilities. The ongoing rise in copper prices will be gradually reflected to end customers.
