

BizLink Announces Third Quarter 2022 Results

Board of Directors have approved third quarter 2022 financial statements: consolidated net sales were NT\$14,526,402 thousand (US\$479,293 thousand), net income (attributable to shareholders of the parent company) was NT\$1,184,084 thousand (US\$39,176 thousand), and consolidated EPS (attributable to shareholders of the parent company) was NT\$7.64 (US\$0.2551).

Third Quarter Operational Highlights:

- Third quarter 2022 sales reached a historical high of NT\$14,526,402 thousand, up 96% YoY. ^{Note 1}
- Net income was NT\$1,184,084 thousand, up 95% YoY. ^{Note 2}
- **Industrial:** three major categories still firm, but with some near-term cyclicity to possibly reduce customers' order optimism.
- **IT DataComm:** Peripherals continuing to slowdown while HPC growth to relax ahead of key server CPU launches in early 2023.
- **Automotive:** major EV customer making year-end push while improving supply chains leading to traction for other EV clients.
- **Electrical Appliances:** premium segment holding up relatively well with others continuing to weaken as consumer wallets tighten.
- **INBG:** overall demand strong with component shortages limiting full near-term sales potential; potential warm winter in Europe.
