### Second Quarter 2018 Results

BizLink Holding Inc. (TWSE: 3665) today reported results for the second quarter of 2018. Audited consolidated net sales totaled a record high NTD 5,255,211 thousand\* (USD 176,594 thousand), an increase of 43.59% (calculations made in NTD. Note 1, 2) from the same period in 2017. Net Operating Income (Consolidated Net Income Attributed to Stockholders of the Company) was NTD 278,468 thousand (USD 9,358 thousand), a decrease of 6.15%. The EPS for this quarter was NT\$2.37 (USD 0.0796).

#### 2018 Q2 Highlights

- Information Technology: The momentum maintained strong for commercial docking stations.
- Motor Vehicle: Harness shipments for the new EV model spiked in end of the quarter. Sales volume for ATV increased due to peak demand in the summer.
- Demand for Medical and Industrial harnesses remained stable.
- Electrical Appliances Harnesses: Q2 revenue was higher than of the previous quarter.

#### **Outlook for the Subsequent Two Quarters**

- Information Technology: An increase shipment for the new docking station is expected. Docking station for the consumer market is launching in the second half of the year.
- Motor Vehicle Harness: Shipments for the new EV model are expected to increase gradually thanks to the steady growth of the customer.
- Medical and Industrial: Overall shipments increases can be expected thanks to the solid demand from customers.
- Electrical Appliances: The rise of copper prices in Q1 will be gradually reflected to end customers.
